We have been engaged to act on the 24th January, 2013 and to report on the budget for the financial year ended **December 31st 2011** which was not in accordance with the Lessors Obligations as per clause 5 (B), I – III of the deed of sub lease which requires these statements to be reported and certified on or before two (2) month subsequent to the close of the reporting year.

Accordingly we do not express an Audit opinion on these Financial Transactions.

That the Proportionate amount to be allocated to each tenant (160 residential lots and 291 townhouse units, rounded to the nearest unit/dollar) in accordance with clause 5, A and B based on the above is Forty Two Trinidad and Tobago Dollars (TT\$42.00) or Four Trinidad and Tobago Dollars (TT\$4.00) per month, per tenant.
