The company engaged only in cash transactions and there were no non-cash items.

We have been engaged to act on the **10th May, 2014** and to report on the budget for the financial year ended **December 31st 2007** which was not in accordance with the Lessors Obligations as per clause 8, 9 and 10 of the seventh schedule of the deed of sub lease which requires these statements to be reported and certified on or before two (2) month subsequent to the close of the reporting year.

Accordingly we do not express an Audit opinion on these Financial Transactions.
