## Minutes of Westmooring Gardens Limited, Annual General Meeting

Date of Meeting: 26<sup>th</sup> Sept 2019

Attendance: 64 Persons of which 12 Directors were present.

## Meeting started 5.32 p.m.

- 1. Welcome and Introduction Mr. Yuille welcomed and thanked everyone for attending. The head table then introduced themselves to the audience.
- 2. Apologies for absence apologies were extended for C. Uhre Admiral Court who would be late and G. Aboud-Porto Villas who is out of the country.
- 3. Confirmation of Minutes, Annual General Meeting held on 8<sup>th</sup> September 2018: Mr. Yuille briefly reviewed the last AGM minutes and then asked the audience if they had any changes to same. With no changes noted it was then confirmed by Francisca Fournillier Commodore Court and seconded by Robert Date Lot owner.
- 4. Matters arising from the minutes No Matters was raised
- 5. Chairman's Report: Mr. Yuille delivered the report (see attached).
- 6. Adoption of the Auditors Report for the year ending 31st December 2018 Mr. Yuille opened the floor for questions regarding our financial report for 2018. With no question/concerns raised, he moved motion to adopt the report which Cathy Maxwell confirmed.
- 7. Re-appoint of Auditors Mr. Yuille advised that the board recommends the re-appointment of R. S. Baboolal and Company as the Auditors for WGL. He asked the audience if they have any issues to our recommendation, with no objection from the floor, and Robert Date's confirmation, R. S. Baboolal and Company was re-appointed for 2019.
- 8. Discussion on security Mr. Yuille advised that what we have done thus far to try and secure the neighbourhood is to install cameras at the Roundabout, Wasa/Recycling area, Buccaneer/Benbow Drive and the office. The cameras in the office also captures the Gazebo and part of the children's playpark. We would like to extend our camera coverage in the neighbourhood however, it would require individuals to give us access to their electricity. He encouraged residents to give us the access and or to install cameras in their homes. Mr. Yuille noted that if residents included a camera or two on their home system to cover the road in front of them, we would definitely extend the camera coverage of our neighbourhood.

Mr. Yuille gave an update into the gating of our neighbourhood in conjunction with our neighbours, Bayshore, Regents Gardens, Regents Park, Regents Point and Regents Towers. He noted that we have been waiting on Bayshore Association to get their approval to commission the gate by Regents Drive West. While they have gotten the approval, from the Diego Martin Regional Corporation (DMRC) it is still not what they wanted, however it is a start to gating the areas from the River to the Yacht Club. The gate is now being closed at 8.00 p.m. and reopened at 6.00 a.m. We are now going to leverage on Bayshore's approval. We have started conversations with a Traffic Engineer who is held in high regard by the DMRC and the Ministry of Works and Transport. The Engineer has requested a Topographic Survey be conducted at the roundabout before he can prepare his plan. His cost is to do a plan alone is within the vicinity of \$70K to \$80K, the benefits to the residents from the River to the Yacht Club outweighs the cost. When we engage the Traffic Engineer services we must have 100% buy in from our residents and the Committees of the various Communities. He noted that all the Committees have expressed an interest in gating the area. Mr. Yuille stated that the actual implementation might cost well over a million dollars, we are not sure how much the Ministry of Works and Transport will pay for but it is still affordable if all the residents buy into it "where there's is a will there's is a way". He advised the audience that many persons from our neighbourhood and the other communities has been asking him when and how we are going to gate the area. He said its easily achievable once we get the approval and the residents are willing to pay the money. Mr. Yuille reiterated that Westmoorings Gardens Limited will not be absorbing the entire cost as the roundabout is used by the other neighbourhoods. He then asked the audience to show their hand if they will support gating the roundabout, the response was favourable.

The floor was opened to take questions on this matter.

- S. Henderson Dolphin Court, asked what the survey is supposed to prove or not prove? Mr. Yuille advised the survey will be used to guide the Engineer with the design and reconfiguration of the area to facility the gates, roads and security booth, etc. Also, to make sure the redesign would not negatively impact the traffic flow.
- B. Ferreira Western Keys, asked we could consider using the empty piece of land by WASA as an access point to our neighbourhood. Mr. Yuille advised that this would be consisted by the Engineer.
- S. Henderson Dolphin Court, asked if gating the neighbourhood is for traffic flow as he thought it was security. Mr. Yuille noted that it is for security however we have to take the traffic flow into consideration to ensure gating does not cause more traffic into the neighbourhood.
- J. Gomes Dolphin Court, stated that gating the neighbourhood would incur additional cost to the residents. She asked how we will enforce all residents to pay this additional cost instead of the few that pays their fees. Mr. Yuille advised that once we agreed to gating the neighbourhood that all residents will be required to pay as it is covered by the deed of sublease.
- S. Henderson Dolphin Court, asked if Westmoorings Gardens Limited is happy with the performance of the securities companies we have around. Mr. Yuille noted the only security company that we employed is Essentia, which we did one month ago for the sole purpose of patrolling the parks, so far, they have been doing a good job.

## 9. Any other business.

- a. M. Isava lot owner, asked what we are doing about the squatters in the park. Mr. Yuille stated that he believed that Mr. Isava is speaking about the residents that have encroached their gardens onto the park. The matter was discussed several times at the board level, a decision was made that we will not destroy the area as its less for us to manage and the property remains ours. Also, this encroachment took place when we didn't have an active board and all new ones have been dealt with since then.
- b. Norine Bazie Schooner Court, gave an example of residents' encroachment that took place in Schooner Court (40) years ago where visitors' parking was taken by residents for their own personal use. At that time, she wasn't aware of the structure and who to take complaints so, hence nothing was done. Mr. Yuille confirmed that the townhouses have its own board and encourages persons to get involved on the board and their neighbourhood so they can stop this kind of things.
- c. N. Patihk Admiral Curt, she supposed and reiterated Mr. Yuille position of residents getting involved on their community. She encouraged the residents to go back to the old days, get to know their neighbours and talk about issues affecting the neighbourhood and find solutions.
- d. D. Rojas Lot Owners, noted that persons are using her personal garbage receptacle as a communal dumpster and she wanted it known that is for her personal use only.
- e. S. Omardeen Lot Owner, noted that the sewer scent coming from the Wasa Station is unbearable and wanted to know if there is anything, we are doing about it. Mr. Yuille advised that the Manager made reports to Wasa and is following up on this matter.
- Lot Owner Buccaneer Drive, he is a new resident and wanted to know if we signed the consent to assign the residual balance of the term of the lease. He wanted to know this in the event he wanted to sell his property who he will have to go to get this consent. He was advised that the Commissioner of State Land is the authority that is responsible for granting the consent. The new resident disagrees with this and stated that the Commissioner of State Land was only part of the process. He went on to say Caribbean Housing and Westmoorings Gardens Limited was also part of the process and he wanted to know what he will have to do if he wanted to sell his house. Mr. Yuille advised that what we, Westmoorings Gardens Limited will provide is a certificate of clearance stating that all fees are paid, and Caribbean Housing or Westmoorings Limited do not get involved any more. The new resident advised that that is not what the lease says and someone needs to check, he went on to say that the lease states Caribbean Housing is the parent company. Mr. Yuille advised that Caribbean Housing is no longer the parent company and that the lease he is referring to is old. He suggested to the new resident to bring the lease in question for us to review and provide him with a proper answer. Mr. Outar - lot owner who worked with the developers for our neighbourhood provided an explanation to the audience and the new residents confirming what Mr. Yuille said.

With no other comments/questions from the floor, Mr. Yuille thanked everyone for their attendance and support. He noted that this was one of the better attended meeting and the decision to change the day to a weekday afternoon seem to have worked. He hoped to see everyone being active in our community and assisting in any where they can,

# Westmoorings Gardens Ltd. Chairman's Report for 2018/2019

Good day fellow directors at the head table, residents, ladies and gentlemen. It is my pleasure to deliver the chairman's report for 2018/2019.

During this period, our focus continued to be the safety of the residents and ongoing maintenance of our neighbourhood.

## **Security**

**Cameras** – All cameras were serviced to ensure that they are fully operational with no defects. The cameras continue to act as a deterrent and be useful to the residents and the police.

**Lights** - We continue to monitor our neighbourhood for defective streetlights and report and follow up with T&TEC for restoration. In our main park, windsurf, we are very mindful of the dark areas and the potential risk to our residents. To this end we replaced 2 defective flood lights and added 2 additional lights to brighten up the park at nights.

**Networking** - We continue to nurture relationships with our neighbouring communities to build synergies in the fight against crime in our neighbourhoods. Also, we continue to have a good relationship with the police services for our area.

**Broken Barrier Cables** – In later part of 2018, the barriers to our empty land next to WASA were damaged which we repaired. That area continues to be secured from vehicular access.

Signage - We installed several neighbourhood watch signs in the 3<sup>rd</sup> quarter of 2019.

**Security Patrols** – Our parks are now being patrolled by Essentia.

### **New Projects**

**Gazebo -** In the later part of 2017, we commenced the planning of a Gazebo for our main park, Windsurf Park. The architectural design was completed at no cost courtesy Lloyd de Suze, our Schooner Court representative. In the early part of 2019, we decided to commence construction in stages due to limited funding. Charles Thavenot spearheaded the project in conjunction with Lloyd de Suze, the first stage of the Gazebo was completed on time and within budget. We acknowledge both Charles and Lloyd for their excellent services.

**Homeowners Guide -** We revised our guide for homeowners in the early part of 2019, which is available on our website. The guide provides useful information for all our residents and we encourage you to review same if you have not done so as yet.

**Revised Park Usage Policy -** Coming out of some activities in our parks that were against our park usage policy, we took a detailed look at our policy and make several changes to protect in the interest of our residents in the second quarter of 2019.

Coming out of that activity, we:

- Notified residents of the changes to our park usage policy.
- Updated our website with the revised policy.
- Upgraded our notice board structures at Windsurf Park and posted new signs with our revised park policy on same.
- Posted new signs with our revised park policy and private property at Seaside Parks.

 Engaged the services of Essentia to assist us with enforcing the policy at our parks.

#### **Finance**

On the financial side of the business, we continue to make good progress with reducing our aged receivables since we embarked on our collection drive in 2015. We are pleased to advise that we have been able to increase the numbers of paying lot owners from 60% as at December 31, 2015 to 96% as at to date. This translates to six lot owners who have to pay for this year and one lot owner for 2018 & 2019. Four service companies still have to pay with one in excess of a year, this is also an improvement from 2015 where the service companies owed on average in excess of two and a half years. To date the receivables, stand at \$145K a reduction from \$393K when we issued invoices in Jan 2019. Also, we assist a couple of our service companies with their accounting and collections. Expenses are well managed, and we operate within our budget.

All our statutory obligations are met and up to date. Audited financials continue to be completed by Auditors, R. S. Baboolal & Co who we are recommending for the following year. Audited financials are up to date as at December 31<sup>st</sup>, 2018.

As you are aware, we are always looking for opportunities to increase our income, we are pleased to advise that we were able to secure a new contract for a billboard in the later part of 2018. We thank the resident who assisted us with this and look forward to residents' suggestions for new opportunity to increase our income.

#### **Common Area Maintenance**

Apart from the ongoing maintenance of the common area parks and grass verges, the following were completed:

- Drain Covers: We continue to repair the steel drain covers that are on Westmoorings Boulevard roadway as the large vehicles are continuously causing damage to the steel plates resulting in loud noise and discomfort to the residents. This year we have seen a reduction in the number of new concrete drain covers installed from 69 to 10 as most of the covers were replaced over the previous years.
- **Roads**: We have written the Diego Martin Regional Corporation on several occasions to repair the potholes/depressions on our roads to no avail, despite this we have been able to source cold mix asphalt at a cost and have repaired the major area of concerns.
- Cleaning of Drains: We continue to follow up with the Chairman of the Diego Martin Regional Corporation to assist our neighbourhood to clean all our drains. We were successful in getting them to clean Buccaneer Drive drain in the 2<sup>nd</sup> quarter of 2019. The Support staff continues to clean the drains that they could access during the dry season.
- **Signage**: We installed several pet signs throughout the neighbourhood in the 3<sup>rd</sup> quarter of 2019. Despite this, pets continue to be a problem and we are kindly asking all residents to please help us by securing and picking up after your pets.

  All the service company signs that needed to be repainted were completed in the first quarter of 2019.
- Water Leaks: We have reported several leaks and successfully followed up for repairs. This
  area is an ongoing battle as our pipes are old and leaks are always springing up. We encourage
  residents with leaks to report the matter to Wasa and inform the office of the reference number
  for us to network with WASA for restoration.
- **Tennis Courts:** Due to the major earthquake in August 2018, a few cracks subsequently appeared which were repaired in November 2018. We note the Tennis Courts continues to be a good income earner and subsidize the residents' service charge fee.

- **Playparks**: We added an additional seesaw in April 2019 to our existing playpark equipment as well as all the equipment was repainted in the first quarter of 2019. Also, all the swings seats were replaced in the last quarter of 2018.
- **Parks**: All benches at both parks were repainted in the first quarter of 2019. Also, overgrown trees were pruned in the first quarter of 2019 in Windsurf Park.
- Recycling: We are committed to promoting recycling in our neighbourhood. We currently have
  an area designed for plastic and glass bottle bins. This area has to be repeatedly cleaned by
  the support staff as people continue to dump non-recyclable garbage. We are again asking the
  residents to stop dumping garbage in the recycling area and please rinse, crush and bag your
  plastics.
- **Networking:** We continue to communicate and develop relationships with the relevant authorities to assist our neighbourhood with leaks, drainage, fire hydrants, garbage, cuttings, rodents, mosquitoes, recycling items, etc.

#### **Social Event**

On the social side of things, we in conjunction with a few moms in the area have successfully hosted our 2<sup>nd</sup> Santa Party for the children in our neighbourhood and their friends. We are hoping for this event to become an annual event on our calendar as we have gotten very positive feedback from the two parties thus far.

In closing, I thank you, the Residents for your continued support and working with us to make our neighbourhood a place to be proud of. Also, thank you to the Directors who give tirelessly of themselves to drive this organization. I look forward to us all working together and networking to continue uplifting our neighbourhood.
